Kara.Vision Privacy Policy

Effective March 1, 2023

This Privacy Policy will apply to your use of Kara.Vision services, available at Kara.Vision.

This Policy is only applicable to our website, and not to any other websites that may be incorporated into this site, or linked from this site by us or our users.

NOTICE CONCERNING CHILDREN

Registered users of Kara.Vision must be 18 or older. We do not direct any of our content specifically at children under 13 years of age, and do not allow children under 13 to register as a user of this site. If we learn or have reason to suspect that a registered user is under age 13, we will promptly delete any personal information in that user's account.

WHAT INFORMATION DO WE COLLECT

Information You Provide to Us. In registering with Kara.Vision, we will require you provide us with information including your name and email address, a user name, and other contact information. If you communicate with us by email, or any other means, any information provided in those communications will be collected from you.

Your Payment Information for Payment Services. We are partnered with one or more payment processing services that allow us to accept credit card and other means of payments from you. We will not have access to or store your credit card numbers (except the last four digits) or the full account numbers of other available means of online payment. We may have access to other information through the payment services such as your physical address.

Automatically Collected Information. When you visit our site, our servers may automatically recognize (1) visitors' domain names; (2) IP addresses (the number assigned to computers on the Internet); (3) device or browser information; and (4) estimated location data. This "traffic data" may be used for marketing purposes or for improving the services we offer.

Cookies and Trackers. We use cookies and other tracking technologies that allow us to store a small piece of data on your computer about your visits to our website. Cookies make your use of our site easier by allowing our platform to remember certain information about your use of the site. Cookies provide us information on the use of our site to help us improve the user experience. You can choose whether to accept cookies by changing the settings on your browser. However, if you choose to disable this function, your experience at our site may be diminished and some features may not work as they were intended.

HOW WE USE YOUR INFORMATION

<u>WE WILL NOT SELL YOUR INFORMATION TO THIRD PARTIES</u>. We only utilize the information you provide us for purposes of providing you with services, the ongoing conduct of business, improving the site and our services.

Use for Operation of Kara.Vision and Providing Services. We use your personal information to verify your identity or credentials, or to contact you to advise you of changes to our site or policy, and related information. We may share your information with our business partners including payment processors and appointment booking services, for the purposes of providing you services you have requested.

Use of Traffic Data and Automatically Collected Data. We use traffic data to analyze our site traffic, but we do not examine this information for individually identifying information. In addition, we may use IP addresses to help diagnose problems with our server, to administer the site, protect our legitimate business interests, or to display the content according to your preferences. Traffic and transaction information may also be shared with business partners and advertisers on an aggregate basis.

Use of Cookies. We may use cookies and other tracking technologies to deliver content specific to your interests, to save your password so you don't have to re-enter it each time you visit our Site, or for other purposes. Third-party information and links on our site may also contain cookies, but we do not have access to or control over information collected by outside parties linked from our site.

DISCLOSURE OF YOUR PERSONAL INFORMATION

Under some circumstances, we may or must disclose your personal information to third parties. These include:

For the Operation of Business and Providing Services. We may share your personal information with contractors, vendors and service providers who support the operation of our platform and site. These support partners have all agreed to uphold the same standards of security and confidentiality that we provide to you under this Policy, and they have agreed to only use your information to carry out their specific business obligations to Kara.Vision.

We may also disclose personal information that you provide to us in the event of a merger, acquisition, or any form of sale of some or all of our assets, in which case personal information we collect via the site will be among the assets transferred to the buyer.

For Legal Purposes. We may share your personal information for the following reasons. If so, we will provide only the minimum amount of information required to:

- Comply with any court order or other legal obligations
- Enforce or apply our Terms and Conditions or other agreements
- Protect rights, property, or safety of our business, our users, or others. This includes exchanging information with other companies and organizations for the purposes of fraud protection, information security, and related matters.

USER CHOICES REGARDING COLLECTION AND USE OF INFORMATION

Your Account Settings. You may visit your personal profile to review and update the personal information we have already collected from you. Note that certain personal information is required to maintain your profile or verification status. If you choose to remove required information, your account profiles may not function properly.

Lost or Stolen Information. You must promptly notify us if your user name, password, or methods of payment are compromised, lost, stolen, or used without permission. In such an event, we will remove that information from your account and update our records accordingly.

SECURITY

The Site has security measures in place to prevent the loss, misuse, and alteration of the information that we obtain from you, but we make no assurances about our ability to prevent any such loss, misuse, to you or to any third party arising out of any such loss, misuse, or alteration.
